DESCRIPTION

FIG. 1 is a perspective view of the safety razor base plate with additional environment shown in broken lines;

FIG. 2 is a bottom perspective view of the safety razor base plate in FIG. 1;

FIG. 3 is a top view of the safety razor base plate in FIG. 1;

FIG. 4 is a front view of the safety razor base plate in FIG. 1;

FIG. 5 is a bottom view of the safety razor base plate in FIG. 1;

FIG. 6 is a rear view of the safety razor base plate in FIG. 1;

FIG. 7 is a left side view of the safety razor base plate in FIG. 1; and,

FIG. 8 is a right side view of the safety razor base plate in FIG. 1.

The design is the visual features of the safety razor base plate shown in solid lines in the drawings. The broken line disclosure of the word ROCKWELL is a registered trademark of Rockwell Razors. The broken line disclosure of the razor in FIG. 1 illustrates the environment. None of the broken lines forms part of the claimed design.

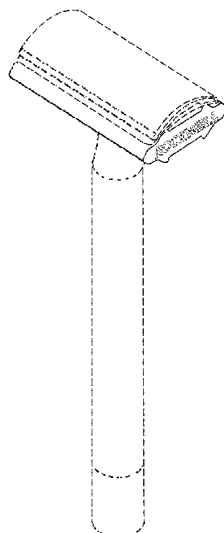

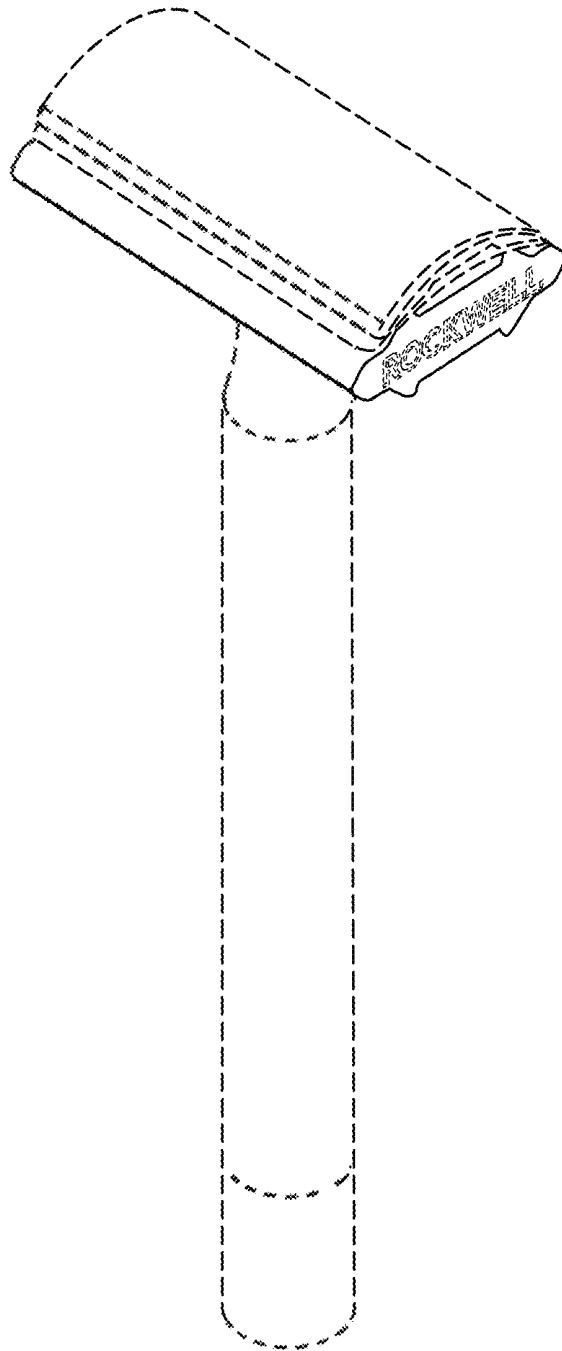

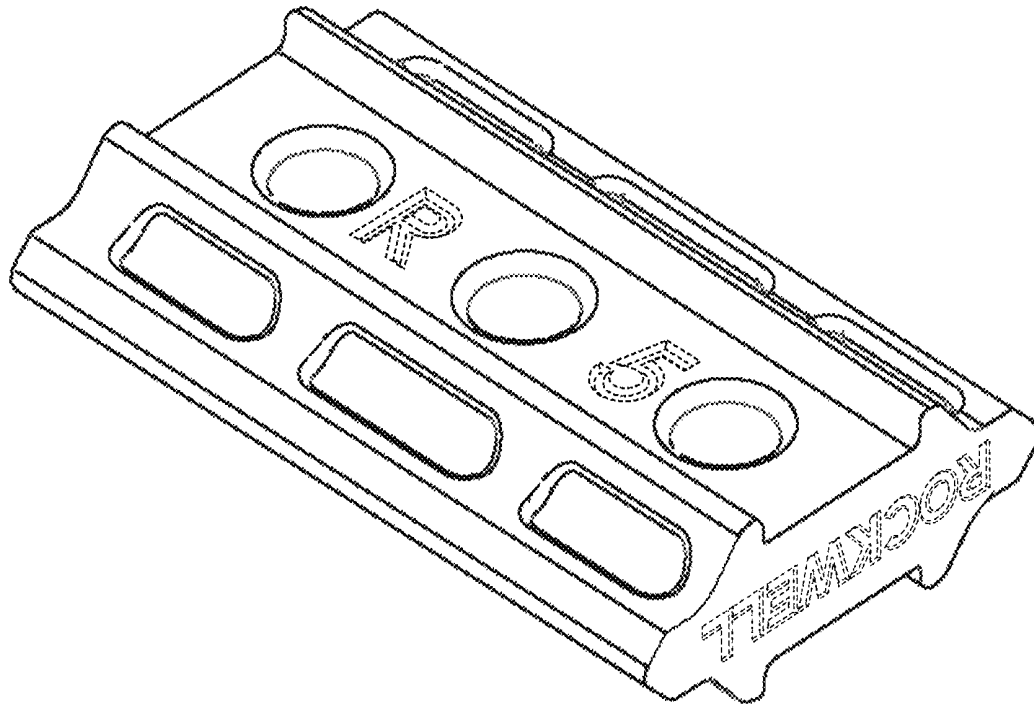

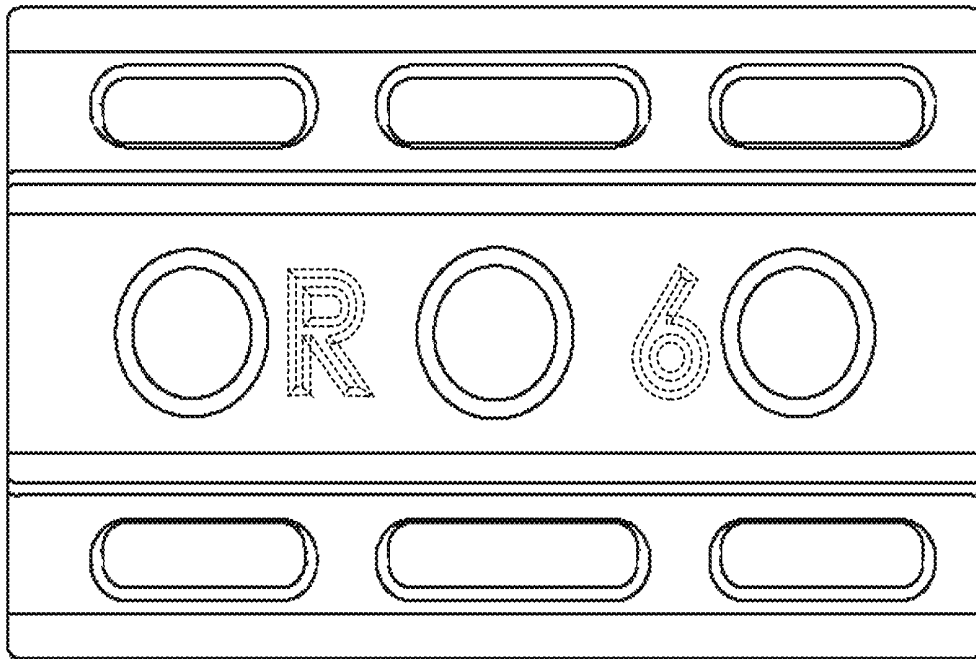

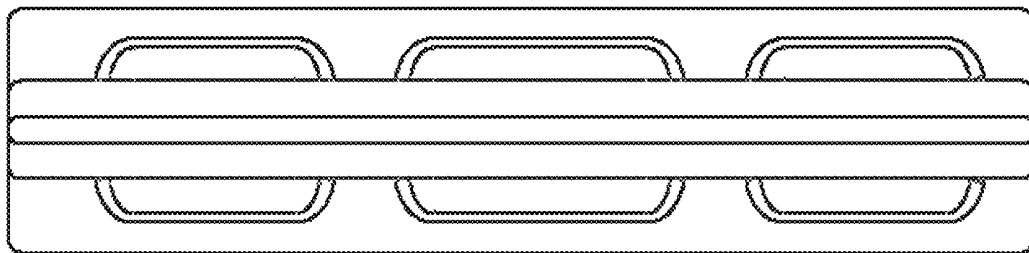

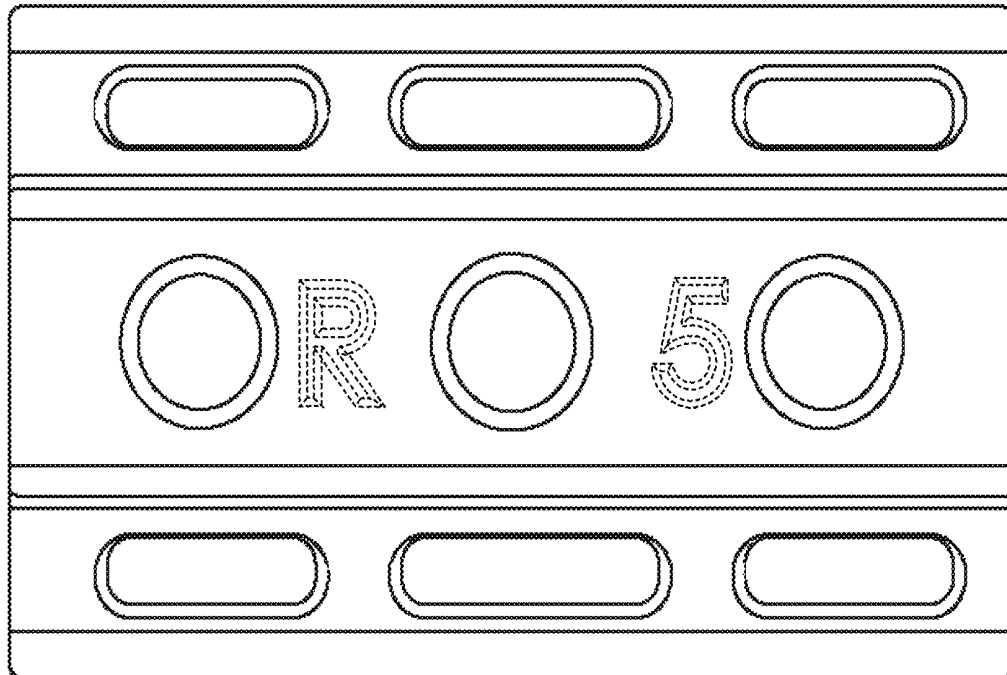

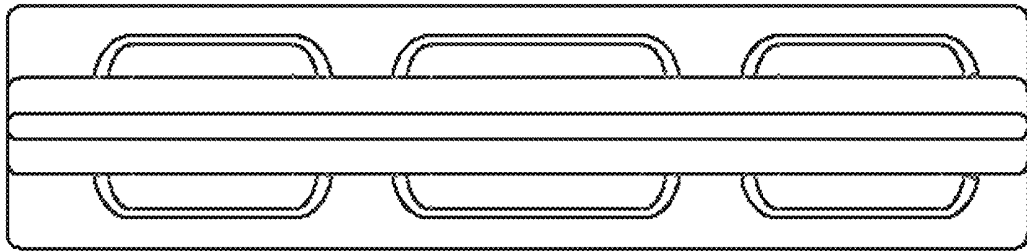

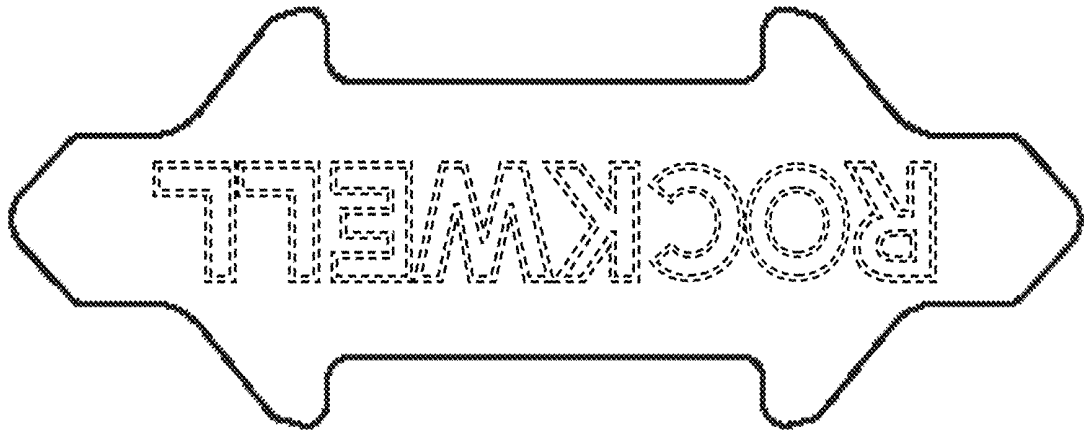

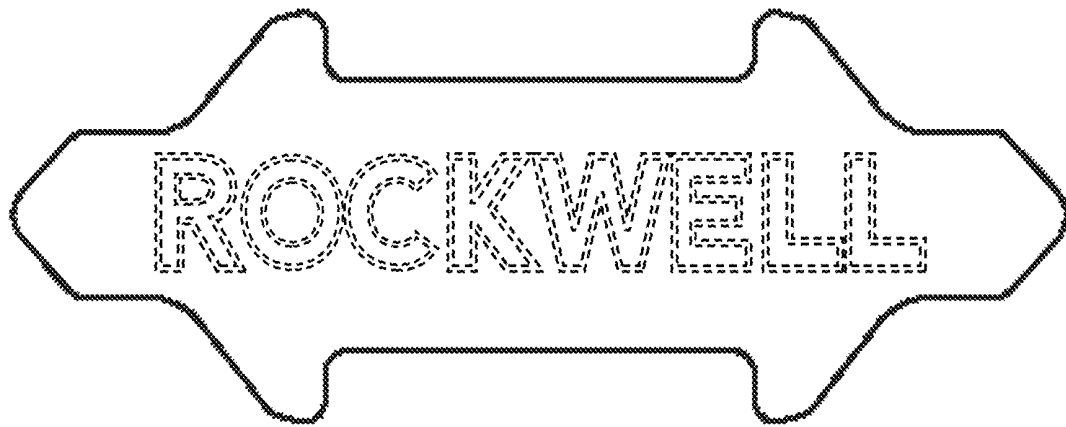
